Any violation of this policy can result in immediate expulsion from the program, and the informing of emergency contacts, at the discretion of GREEN Staff members and/or hotel personnel. GREEN holds the right to act in the best interest of any intoxicated, high, or drug-influenced student, which includes hospitalization, police intervention, or program expulsion.
